The Centre for Nano and Soft Matter Sciences (CeNS), located in Jalahalli, Bengaluru, is an Autonomous scientific research institute under Department of Science and Technology (DST), Government of India, involved in advanced research and development in Nanoscience.

The Jawaharlal Nehru Centre for Advanced Scientific Research (JNCASRAn Autonomous Institution under Department of Science and Technology, Govt. of India andan Institution Deemed to be University, located in Jakkur, Bengaluru is a premier scientific research institution carrying out research in multidisciplinary fields.

A new campus, named 'Arkavathi' is being developed for research and development activities at Survey No. 7, Shivanapura Village, Dasanapura Hobli, Bengaluru North Taluk. A portion of the site has already been developed and a laboratory block is already functioning. Presently, the second phase of construction of blocks is being taken up. These two institutions have jointly proposed to construct Laboratory Blocks and a Hostel block within the Arkavathi campus.

The proposed construction work is bifurcated into three distinct projects, namely (i) CeNS Laboratory and Administration Block (PART-A), (ii) CeNS Hostel Block (PART-B) and (iii) JNCASR Pre-fab Innovation and Development Block (PART-C).

While Parts A and B above will be under the jurisdiction of CeNS, Part-C will be under the control of JNCASR. Though the two institutions have combined the Tender process, each part shall be considered as separate projects within a single campus and construction taken up simultaneously. The respective institutions shall issue the Work Orders for each Part and the cost of construction of the blocks will be borne respectively. The modalities of the tendering process, placing the Work Orders and the process of payments shall be detailed in the tender pre-bid meeting and the specifics shall be provided in the form of a booklet for reference.

Both the Institutions welcome responses from Builders of repute and good standing, for a fruitful association.
